



RESOLUTION NO. 06-14

A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF TAOS DECLARING CERTAIN PROPERTY TO BE EXCESS PROPERTY AND PROVIDING FOR DISPOSAL OF SUCH PROPERTY

WHEREAS, the Town of Taos is in possession of certain assets owned by the municipality which the municipality is no longer in need of; and

WHEREAS, The Town has determined that it is in the best interest of the Town to declare such property as excess property and dispose of the property pursuant to law; and

WHEREAS, the Town Council desires to lease this excess vehicle to the Taos County Arc.

NOW, THEREFORE, BE IT RESOLVED,

1. The Town is the owner of a ¹⁹⁹⁴2004 Ford/Cutaway vehicle which is hereby declared to be excess property;
2. The Taos County Arc is in need of a vehicle to provide transportation services to those citizens of the community which utilize their services;
3. The Town hereby expresses it's intent to serve the public purpose of providing transportation to citizens of the community by entering into a lease agreement with the Taos County Arc for the use of excess property by Taos County Arc.
4. The Town and the Taos County Arc shall enter into a Memorandum of Understanding specifically for this purpose.

PASSED, ADOPTED, AND APPROVED, this 21st day of February 2006 at the Regular Meeting of the Town Council.

**MEMORANDUM OF UNDERSTANDING BETWEEN
THE TOWN OF TAOS
AND TAOS COUNTY ARC**

This agreement is between the Town of Taos and Taos County Arc, a nonprofit organization.

WHEREAS, the Town has declared a 1994 Ford/Cutaway vehicle to be excess property; and

WHEREAS, the Taos County Arc has expressed its need for such vehicle in order to provide transportation services to those community members in need of their services; and

Now, **THEREFORE**, be it agreed upon by the Town and the Taos County Arc:

1. The Town of Taos agrees to lease the aforementioned vehicle to the Taos County Arc at an annual lease of \$1.00 per year.
2. The Taos County Arc shall provide transportation services to members of the community who utilize their services;
3. The Taos County Arc is responsible for all insurance and maintenance of the vehicle;
4. The Taos County Arc agrees to indemnify, defend and hold harmless the Town from any all claims, suits, and causes of action which may arise from Taos County Arc's use of the vehicle.
