RESOLUTION 09-39**

**A RESOLUTION OF THE TOWN OF TAOS, NEW MEXICO, AUTHORIZING THE SUBMISSION OF A NEW MEXICO COMMUNITY DEVELOPMENT BLOCK GRANT PROGRAM APPLICATION TO THE DEPARTMENT OF FINANCE AND ADMINISTRATION/LOCAL GOVERNMENT DIVISION; AND AUTHORIZING THE MAYOR TO ACT AS THE TOWN OF TAOS CHIEF EXECUTIVE OFFICER AND AUTHORIZED REPRESENTATIVE IN ALL MATTERS PERTAINING TO THE TOWN OF TAOS PARTICIPATION IN THE COMMUNITY DEVELOPMENT BLOCK GRANT PROGRAM.**

**WHEREAS**, the Town Council adopted the Vision 2020 Master Plan in February, 1999; and

**WHEREAS**, the need exists within the Town of Taos to update to the Vision 2020 Master Plan to identify the existing and future land uses and development within neighborhoods in several low and moderate income neighborhoods, and the Town of Taos desires to apply to the Housing and Urban Development's Community Development Block Grant Program to obtain funding for the neighborhood improvement projects; and

**WHEREAS**, the Town Council held a public hearing on July 14, 2009 for public input and comment during the 2009 application process; and

**WHEREAS**, the Town Council finds that there is a significant need to undertake the Comprehensive Land Use Plan project to provide adequate services to the community; and

**WHEREAS**, The Town Council determines that the Comprehensive Land Use Plan meets the requirements of the Community Development Block Grant Program.

**NOW, THEREFORE BE IT RESOLVED BY THE GOVERNING BODY OF THE TOWN OF TAOS, NEW MEXICO, that**

1. The Town of Taos is hereby authorized to prepare and submit a Community Development Block Grant application to the New Mexico Department of Finance and Administration/Local Government Division for the Comprehensive Land Use Plan;

2. That the Town Council directs and designates the Mayor as the Town of Taos Chief Executive Officer and Authorized Representative to act in all matters in connection with this application and the Town of Taos participation in the New Mexico Community Development Block Grant Program.
3. The Town of Taos officials and staff are directed to do any and all acts necessary to carry out the intent of this Resolution.
4. That the application be for \$50,000 of grant funds to carry out the Comprehensive Land Use Plan;
5. That it further be stated that the Town of Taos is committing \$5,000 from its General Fund as a cash contribution toward the Comprehensive Land Use plan.
